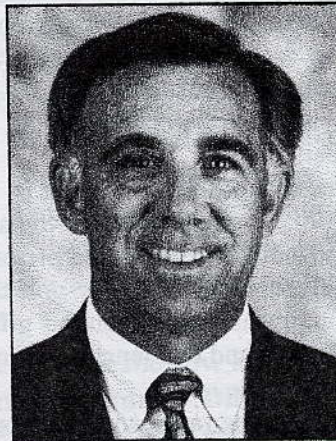
## Election of Officers

Ricco kept the guests up and moving out of their seats with trivia questions and dances. Approximately 500 alumni from the four former city high schools enjoyed the evening.

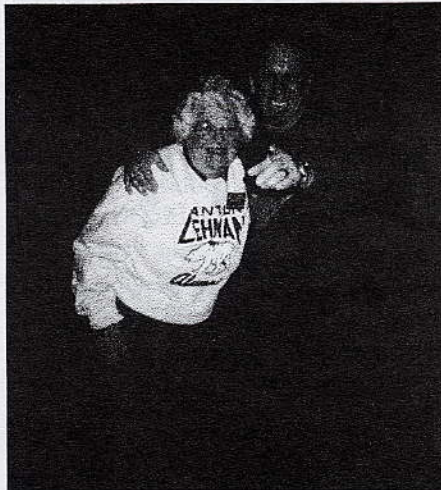
Each of the alumni associations received \$550. from the event which was a far cry from the \$4000. that we received last year when the event also included the proceeds from an alumni basketball game.
